I have audited the accompanying Annex B Schedule of Salaries, Honoraria, Travel Expenses, and Other Remuneration for Elected or Appointed Officials of Mistawasis First Nation for the year ended March 31, 2014.

Management's Responsibility for the Consolidated Financial Statements
